- Completely filled Application Form (including accurate credit card details).
- Copy of your Certificate of Employment (COE), indicating your position, date of employment commencement, and salary details.
- Copies of your three (3) most recent pay slips.
- Copies of two (2) valid IDs, comprising one company ID and one governmentissued ID. Ensure that these IDs include three (3) specimen signatures.

For SELF-EMPLOYED Individuals

- Thoroughly completed Application Form (including accurate credit card details).
- Copy of your Business Permit.
- Copy of your DTI Registration.
- Copies of two (2) valid government-issued IDs, each with three (3) specimen signatures.

A Gross Annual Income of at least Php 240,000 is required.

NOTE: If you currently hold an active credit card for a minimum of nine (9) months, please include a copy of the card's front side in your application.
